SUBJECT: HAFB COVID-19 Directive 1, Change 4 - Establishment of Local Leave Area

References: (a) Deputy SECDEF Memo, 13 March 2020, Stop Movement for all Domestic Travel

for DoD Components in Response to Coronavirus Disease 2019

(b) AFI 36-3003, Military Leave Policy

- 1. On 13 Mar 20, the Department of Defense (DoD) issued a stop movement directive for all domestic travel in response to the 2019 Novel Coronavirus (COVID-19). This directive states that military members are only authorized local leave in accordance with Service policies.
- 2. For the duration of the DoD travel directive related to COVID-19, the local leave area for Holloman AFB (HAFB) military personnel is within 50 miles. This distance includes but is not limited to: Alamogordo, Tularosa, La Luz, Cloudcroft, Ruidoso, and Sierra Blanca recreation areas. This geographic restriction also applies to regular pass days and scheduled days off.
- a. Members living in El Paso <u>and Las Cruces</u> are approved to transit to/from <u>HAFB despite travel outside 50 miles</u>. Travel to El Paso <u>and Las Cruces</u> for all other <u>active duty, guard, & reserve</u> personnel requires squadron commander approval.
- b. Members living in Las Cruces are approved to transit to/from Las Cruces and Alamogordo. Travel to Las Cruces for all other active duty personnel is only approved for basic essentials.
- 3. Waiver authority to this directive are as follows:
- a. <u>Unit Commanders to include Detachment Commanders</u> Squadron Commander may approve request for overnight stays beyond one's primary or secondary residence. Secondary residences include cabins and homes, but does not include campers, tents, etc.
 - b. First O-6 in member's chain may approve travel outside of 50 miles, with notification to the 49 WG/CC.
- 4. Members with scheduled medical appointments beyond the local leave area are permitted to travel, but must inform their squadron commander before departure.
- 5. 49th Wing personnel with duty at and/or living on White Sands Missile Range (WSMR) will follow the more restrictive of this guidance or the WSMR/CC guidance.
- 6. Similar to other travel guidance regarding COVID-19, travel exceptions may be granted for compelling cases where the travel is mission-essential, for humanitarian reasons, or warranted due to extreme hardship. If your travel plans fall into one of these categories, please work the request through your squadron commander.
