

#### BASE ACCESS FAQ:

**Q1. I live (or my dependent lives) on base and have been to another state outside of NM/El Paso recently. Will I be allowed to come on base to my home?**

A1. Yes. However, you (and your family) may be asked to remain under Restriction of Movement at your home until being cleared by 49 MDG Public Health if you:

1. Have tested positive for COVID-19.
2. Have had direct contact with anyone who has tested presumptive positive or confirmed positive for COVID-19.
3. Have been outside of New Mexico/El Paso after 11 March 2020.
4. Have been in a foreign country after 1 March 2020.

**Q2. I live off base. Will my dependent(s) or I be allowed on base if we have been outside of NM/El Paso?**

A2. If anyone meets the criteria in A1 and resides off base, they may not be allowed on base until being cleared by 49 MDG Public Health, unless they need medical care or are deemed mission essential.

**Q3. Can I still have guests come visit me on base?**

A3. Yes, but they will be required to meet all screening criteria.

**Q4. My situation has not been addressed here, what do I do?**

A4. You should contact 49th MDG Public Health at (575) 572-4887 to discuss your concern.

#### CHILD & YOUTH PROGRAM FAQ:

**Q1. Can my child still participate in the Child Development & Youth Centers at Holloman?**

A1. Effective March 16, children who have been outside of the state of NM/El Paso in the previous 14 days will be subject to additional screening before admittance.

**Q2. What if these restrictions affect my ability to come to work?**

A2. If you are required to spend more time at home caring for your children, please contact your 1st Sgt or Sq/CC for further coordination.

## LOCAL LEAVE AREA FAQ

### **Q1. What are the domestic travel restrictions imposed for active duty military members?**

A1. On March 13, the DoD issued a stop movement for all domestic travel for all active duty military. Active duty Holloman military members are only authorized local leave.

### **Q2. What is the local leave policy for Holloman AFB?**

A2. The local leave area for Holloman AFB military personnel is within 50 miles, which includes, but is not limited to, the communities of Alamogordo, Tularosa, La Luz, Cloudcroft, Mescalero, Ruidoso, and the Lincoln National Forest recreation areas.

### **Q3. Do the domestic travel restrictions and local leave policy apply to DoD civilians, contractors and active duty family members?**

A3. No, they do not. Currently, there is no restriction stopping nonservice members from travel; however, anyone travelling outside the local area does increase their potential chance of exposure. Additionally, the base commander may restrict base access upon return.

### **Q4. What if I live in El Paso and work at Holloman?**

A4. Members living in El Paso are approved to commute to/from El Paso and Alamogordo for work. Travel to El Paso for all other active duty personnel requires squadron commander approval.

### **Q5. What if I live in Las Cruces and work at Holloman?**

A5. Members living in Las Cruces are approved to commute to/from Las Cruces and Alamogordo for work. Travel to Las Cruces for all other active duty personnel is only approved for basic essentials.

### **Q6. What if I live on White Sands Missile Range (WSMR) and work at Holloman?**

A6. Holloman personnel who work at Holloman AFB but live at WSMR will follow whichever Command guidance is more restrictive. WSMR residents will be permitted to travel to Las Cruces.

### **Q7. What if I have a medical appointment beyond the local leave area?**

A7. Members with scheduled medical appointments beyond the local leave area are permitted to travel, but must inform their squadron commander before departure.

### **Q8. I live in El Paso/Las Cruces/WSMR. Can I continue to go shopping at my local grocery stores and utilize other local services?**

A8. Yes. We ask that you practice high standards of social distancing (6 feet or more) and personal hygiene. If at all possible, limit visits to bars, restaurants and other nonessential businesses. Avoid places where there are large crowds. If you can conduct business over the phone, through the mail, or through email, please do so instead of face-to-face contact.

### **Q9. I already have leave planned/purchased—does this mean it is cancelled?**

A9. Yes. All non-local leave through May 11, with rare exception, is now unauthorized.
