## March 2015

Below are the administrative actions taken by the 49th Wing during the month of March 2015. Names are withheld when appropriate to the forum. One of the most sacred principles in the justice system is that a defendant is innocent until proven guilty beyond a reasonable doubt.

### Court-Martial:

- None

### Article 15 Action:

- A Staff Sergeant, 49th Material Maintenance Squadron, received nonjudicial punishment for assault. Punishment consisted of reduction to the grade of Senior Airman and a reprimand.

### Administrative Discharges:

- An Airman, 49th Security Forces Squadron, was discharged for Minor Disciplinary Infractions: numerous instances of failing to report for duty, DUI, underage drinking, and careless driving. Member received a General Discharge, resulting in loss of GI bill benefits.
- An Airman, 49th Security Forces Squadron, was discharged for Drug Abuse and Minor Disciplinary Infractions. The Drug Abuse consisted of member taking a hydrocodone pill prescribed to another AF member. The Minor Disciplinary Infractions consisted of: failing to pay debt, numerous instances of failing to adhere to AF dress & appearance standards, failing to adhere to dorm room standards, and two instances of failing to adhere to the posted speed limits on base. Member received a General Discharge, resulting in loss of GI bill benefits.
- An Airman Basic, 49th Security Forces Squadron, was discharged for Drug Abuse: member wrongfully used marijuana and hydrocodone. Member received a General Discharge, resulting in loss of GI bill benefits.
- An Airman First Class, 16th Training Squadron, was discharged for Minor Disciplinary Infractions: numerous instances of failing to obey lawful orders, failing to be honest, dereliction of duty, and failing to report for duty on-time. Member received a General Discharge, resulting in loss of GI bill benefits.
- An Airman Basic, 16th Training Squadron, was discharged for Drug Abuse: member wrongfully used a hallucinogenic drug. Member received a General Discharge, resulting in loss of GI bill benefits.
- An Airman First Class, 16th Training Squadron, was discharged based on Minor Disciplinary Infractions: numerous instances of failing to report for duty on-time, failing to adhere to dress & appearance standards, arrested for suspicion of driving under the influence, and failing to adhere to dorm room standards. Member received a General Discharge, resulting in loss of GI bill benefits.

### **Administrative Demotions:**

- A Technical Sergeant from the 54th Aircraft Maintenance Squadron received an administrative demotion action for failure to maintain or demonstrate the ability and willingness to attain physical fitness standards. The member failed his Fitness Assessment three times in a 24 month period, and the member was subsequently demoted to the rank of Staff Sergeant.
- An Airman First Class from the 49th Logistics Readiness Squadron received an administrative demotion action for Failure to Fulfill Airman Responsibilities after being arrested by the Battle Creek Police Department in Michigan for driving a vehicle under the influence of alcohol. The member was demoted to the rank of Airman.
