## May 2015

Below are the administrative actions taken by the 49th Wing during the month of May 2015. Names are withheld when appropriate to the forum. One of the most sacred principles in the justice system is that a defendant is innocent until proven guilty beyond a reasonable doubt.

### Courts-Martial:

- None

### Article 15 Actions:

- A Senior Airman, 49th Force Support Squadron, received nonjudicial punishment for failing to go to their appointed place of duty. Punishment consisted of forfeiture of \$1,061.00, 45 days extra duty, and a reprimand.

### Administrative Discharges:

- An Airman First Class, 49th Materiel Maintenance Squadron, was discharged for Drug Abuse, wrongful use of marijuana. Member received a General service characterization, resulting in the loss of GI bill benefits.
- An Airman First Class, 49th Security Forces Squadron, was discharged for Minor Disciplinary Infractions. Member was derelict in the performance of his duties, failed to maintain POV registration, failed twice to report for duty at the appointed time, failed to adhere to dorm room standards, was twice past due on his debt, violated the dorm policy, failed four times to adhere to Dress and Appearance Standards, and failed to go to a medical appointment. Member received a General service characterization, resulting in the loss of GI bill benefits.
- A Senior Airman, 49th Medical Support Squadron, was discharged for Minor Disciplinary Infractions. Member was derelict in the performance of his duties, failed three times to report for duty at the appointed time, used his GTC for unauthorized purchases, failed to conduct himself in a professional manner during an intramural sports game, failed to obey an order, failed to fulfill his commitment for which he was given time off work, resisted arrest, obstructed justice, and concealed his identity from the Alamogordo Police Department. Member received a General service characterization, resulting in the loss of GI bill benefits.
- An Airman First Class, 49th Security Forces Squadron, was discharged for Failure in Alcohol Abuse Treatment. Member received an Honorable service characterization.

### *Administrative Demotions:*

- A Master Sergeant, 49th Logistics Readiness Squadron, received an administrative demotion for Failure to Fulfill SNCO Responsibilities for driving a vehicle under the influence of alcohol. The member was demoted to the rank of Technical Sergeant.
- A Technical Sergeant, 49th Civil Engineer Squadron, received an administrative demotion action for failure to maintain or demonstrate the ability and willingness to attain physical fitness standards. The member failed his Fitness Assessment three times in a 24 month period, and he was subsequently demoted to the rank of Staff Sergeant.
