Below are the actions taken at Holloman AFB during the month of October 2015.

Names are withheld when appropriate to the forum.

Courts-Martial:

- On 29 Oct 15, a member of 49 SFS was acquitted by a panel of officer members of one charge and specification of wrongful use of d-methamphetamine.

Article 15 Actions:

- A Captain, 6 RS, received an Article 15 for unlawfully grabbing and pushing their spouse. The member received a forfeiture of \$500.00 pay and a reprimand.
- A Staff Sergeant, 49 CES, received an Article 15 for making a false official statement. The member received a reduction to the grade of Senior Airman and a reprimand.
- An Airman First Class, 49 CES, received an Article 15 for unlawfully touching two individuals on the chest and buttocks. The member received a suspended reduction to the grade of Airman and a reprimand.
- An Airman, 16 TRS, received an Article 15 for stealing clothing from the BX. The member received a reduction to the grade of Airman Basic, restriction to the limits of Holloman Air Force Base, New Mexico, for 30 days, and a reprimand.
- A Senior Airman, 49 SFS, received an Article 15 for being drunk on duty. The member received a reduction to the grade of Airman First Class, with a suspended reduction to Airman, and a reprimand.
- A Senior Airman, 7 ASOS, received an Article 15 for stealing clothing from the BX. The member received a suspended reduction to the grade of Airman First Class, 30 days extra duty, and a reprimand.

Administrative Discharges:

- An Airman First Class, 54th AMXS, was discharged for Failure to Meet Minimum Fitness Standards. The member failed four fitness assessments within a 24 month period. The member received an Honorable discharge characterization.
- An Airman, 49th SFS, was discharged for Conditions that Interfere with Military Service—Adjustment Disorder with Anxious and Depressed Mood, Severe. Member received an Honorable discharge characterization.
- An Airman First Class, 49th OSS, received Probation and Rehabilitation (P&R) for 6 months for Minor Disciplinary Infractions. The member's misconduct consisted of: wrongfully consuming alcoholic beverages while under the age of 21 on two occasions, reporting late for duty on three occasions, failing to follow proper leave procedures, lacking military bearing, having poor work performance, and for failing to maintain a clean dorm room. If the member does not comply with the terms of the P&R during the 6 months, the member will be discharged.
