Below are the actions taken at Holloman AFB during the month of January 2016. Names are withheld when appropriate to the forum. See our new feature, the "Tip of the Month."

Courts-Martial: None

Article 15 Actions: None

Administrative Discharges:

- An Airman First Class, 49 AMDS, was discharged for Commission of a Serious Offense and for Minor Disciplinary Infractions. The member's misconduct includes: misappropriation of personal property. Further misconduct consists of failure to go x3, failure to perform duties x3, and rude/disrespectful behavior to senior leadership. Member received a General discharge service characterization, resulting in the loss of GI bill benefits.
- An Airman Basic, 49 SFS, was discharged for Drug Abuse and Minor Disciplinary Infractions. The member's misconduct includes: wrongful use of marijuana and Tetrahydrocannabinol, failure to go x4, and dereliction of duty for failure to secure a building. Member received a General discharge service characterization, resulting in the loss of GI bill benefits.
- A First Lieutenant, 49 WG, was discharged for Serious or Recurring Misconduct Punishable by Military or Civilian Authorities. The member's misconduct includes: physically controlling a vehicle while drunk, drunk in a public place while in uniform, drunk on duty, and consuming alcohol while enrolled in the Alcohol and Drug Abuse Prevention and Treatment Program. Member received a General discharge service characterization.

Administrative Demotions:

- An Airman First Class, 49 SFS, was demoted for failure to fulfill Airman responsibilities, specifically the member was driving under the influence. The member was demoted to the rank of Airman.
