Below are the actions taken at Holloman AFB during the month of April 2016.

Names are withheld when appropriate to the forum.

Courts-Martial:

- None

Article 15 Actions:

- A Senior Airman, 49 CS, received an Article 15 for wrongful use of marijuana. The member received a suspended reduction to the grade of Airman First Class and 11 days extra duty. (Member was discharged. See below.)
- A Staff Sergeant, 54 FG, received an Article 15 for wrongful use of Methylenedioxy-Amphetamine and wrongful use of d-Amphetamine. The member received a reduction to Senior Airman, forfeiture of \$548, and 14 extra days. (Member was discharged. See below.)
- A Staff Sergeant, 49 LRS, received an Article 15 for forging an Air Force Fitness Assessment Scorecard. The member received a reduction to Senior Airman, 30 days extra duty, and a reprimand.
- A Senior Airman, 49 LRS, received an Article 15 for operating a vehicle drunk. The member received a reduction to Airman First Class, restriction to Holloman AFB for 30 days, and a reprimand.
- An Airman First Class, 49 SFS, received an Article 15 for dereliction of duty by wrongfully drawing their firearm for non-duty related purposes. The member received a reduction to Airman with a suspended reduction to Airman Basic and a reprimand.
- A Second Lieutenant, 54 OSS, received an Article 15 for fraternizing with an enlisted member and violating a no contact order. The member received forfeitures of \$1,486.00 for 2 months and a reprimand. The portion of forfeitures over \$750.00 per month was suspended for six months.

Administrative Discharges:

- A Senior Airman, 49 CS, was discharged for Drug Abuse. The member's misconduct consisted of: wrongful use of marijuana. The member received a General discharge characterization, resulting in the loss of GI bill benefits.
- A Senior Airman, 54 FG, was discharged for Drug Abuse. The member's misconduct consisted of: wrongful use of Methylenedioxy-Amphetamine, and wrongful use of d-Amphetamine. The member received a General discharge characterization, resulting in the loss of the loss of GI bill benefits.
- An Airman First Class, 49 OSS, was discharged for Conditions that Interfere with Military Service. Member received an Honorable discharge characterization.
- An Airman First Class, 49 CES, was discharged for Minor Disciplinary Infractions. The member's misconduct consisted of: failure to have current registration, failure to uphold dorm room standards x5, failure to report as ordered, disrespectful, damage to government property, failure in the performance of duties, failure to obey a direct order x4, lying to a SNCO, failure to go x6, and asleep on duty. Member received a General discharge characterization, resulting in the loss of GI bill benefits.

- An Airman First Class, 49 MMS, was discharged for Minor Disciplinary Infractions. The member's misconduct consisted of: failure to obey, failure to uphold dorm room standards x3, failure in performance of duties x3, failure to adhere to dress & appearance standards, and failure to secure Privacy Act Information & the member's CAC. The member received a General discharge characterization, resulting in the loss of GI bill benefits.
- An Airman, 49 MMS, was discharged for a Pattern of Misconduct, Conduct Prejudicial to Good Order and Discipline. The member's misconduct consisted of: operating a vehicle while drunk, and being drunk and disorderly. The member received a General discharge characterization, resulting in the loss of GI bill benefits.
- A Staff Sergeant, 49 OSS, was discharged for Pattern of Misconduct, Conduct Prejudicial to Good Order and Discipline. The member's misconduct consisted of: reporting to duty incapacitated because member was intoxicated, failure to go, drunk and disorderly, and missing movement of a PCS flight. The member received a General discharge characterization, resulting in the loss of GI bill benefits.
- **Administrative Demotions:**
- A Staff Sergeant, 49 MDOS, was demoted to Senior Airman for failing to fulfill NCO responsibilities and standards.
- A Senior Airman, 49 SFS, was demoted to the rank of Airman First Class for failing three fitness assessments within 24 months.
- **Tip of the Month:**
- IAW AFI 51-202, *Nonjudicial Punishment*, Table 3.1, a commander, Lieutenant Colonel or above, imposing Article 15 punishment on a member Senior Airman or below has the authority to impose a reduction in grade all the way to Airman Basic. However, on a Staff Sergeant, Technical Sergeant, or Master Sergeant, the same commander may only impose a one grade reduction.
