Below are the actions taken at Holloman AFB during the month of July 2016.

Courts-Martial:

- None.

Article 15 Actions:

- A Senior Airman, 49th Civil Engineering Squadron, received an Article 15 for signing a false official record and failing to report for duty. The member received a reduction in rank to Airman First Class and a reprimand.
- An Airman First Class, 49th Civil Engineering Squadron, received an Article 15 for wrongful use of Marijuana. The member received a reduction in rank to Airman Basic, restriction to the limits of Holloman Air Force Base for 60 days, and a reprimand.
- A Staff Sergeant, 49th Aircraft Maintenance Squadron, received an Article 15 for reckless driving. The member received a reduction in rank to Senior Airman and a reprimand.
- An Airman First Class, 49th Aircraft Maintenance Squadron, received an Article 15 for failing to report for duty and violating a technical order. The member received a suspended reduction in rank to Airman and a reprimand.
- A Staff Sergeant, 49th Maintenance Group, received an Article 15 for wrongful use of Hydrocodone and Hydromorphone. The member received a reduction in rank to Senior Airman and a reprimand.
- A Senior Airman, 54th Maintenance Squadron, received an Article 15 for making a false official statement and dereliction of duty. The member received a suspended reduction in rank to Airman First Class, a suspended forfeiture of \$1,041.00, 7 days of extra duty, and a reprimand.

Administrative Discharges:

- A Senior Airman, 49th Security Forces Squadron, was discharged for Conditions that Interfere with Military Service. Member received an Honorable discharge characterization.

Administrative Demotions:

- A Senior Airman, 54th Aircraft Maintenance Squadron, was demoted to the rank of Airman First Class for failing to fulfill Airman responsibilities and standards.
