Below are the actions taken at Holloman AFB during the month of March 2016.

Names are withheld when appropriate to the forum.

#### Courts-Martial:

None

#### Article 15 Actions:

- A Staff Sergeant, 49 MXS, received an Article 15 for being drunk and disorderly on a commercial flight. The
  member received 14 days extra duty.
- A Senior Airman, 49 CES, received an Article 15 for wrongfully using Marijuana. The member received a
  reduction to the grade of Airman First Class and a reprimand. Member was subsequently discharged for Drug
  Abuse (see below).

#### Administrative Discharges:

- An Airman, 54 AMXS, was discharged for Failure to Meet Minimum Fitness Standards. The member failed 4 fitness assessments within a 24 month period. Member received an Honorable discharge characterization.
- An Airman First Class, 49 MMS, was discharged for Minor Disciplinary Infractions. The member's
  misconduct consisted of: failure to uphold dorm room standards x5, insubordination and disrespect to an
  NCO and SNCO, speeding, dereliction of duty, and for failure to report for duty at the time prescribed.
  Member received a General discharge characterization, resulting in the loss of GI bill benefits.
- An Airman First Class, 49 CES, was discharged for Drug Abuse. The member wrongfully used marijuana. Member received a General discharge characterization, resulting in the loss of GI bill benefits.
- A Captain, 49 MDOS, was discharged for Serious or Recurring Misconduct Punishable by Military or
  Civilian Authorities. The member's misconduct consisted of fraternizing with an enlisted member in his
  squadron, including carrying on a sexual relationship with the enlisted member, who was not his spouse.
   Member received a General discharge characterization and recoupment of special pay.

#### Administrative Demotions:

- A Staff Sergeant, 49 OSS, was demoted for Failure to Keep Fit. The member failed three fitness assessments in 24 months. The member was demoted to the rank of Senior Airman.
- A Staff Sergeant, 49 CS, was demoted for failure to fulfill Airman responsibilities. Specifically, the member
  drove while drunk, causing a three car accident in Alamogordo, NM. The member was demoted to the rank of
  Senior Airman.
