Below are the actions taken at Holloman AFB during the month of August 2016.

Courts-Martial:

- None.

Article 15 Actions:

- A Senior Airman, 49th Civil Engineering Squadron, received an Article 15 for assault and willfully destroying the personal property of another. The member received a suspended reduction in rank to Airman First Class and a reprimand.
- A Senior Airman, 49th Security Forces Squadron, received an Article 15 for drunk driving on base and negligently damaging military property. The member received a reduction in rank to Airman Basic and a reprimand.

Administrative Discharges:

- An Airman, 49th Logistics Readiness Squadron, was discharged for conditions that interfere with military service. Member received an Honorable discharge characterization.
- An Airman, 49th Maintenance Support Squadron, was discharged for minor disciplinary infractions. Member received an Under Honorable Conditions (General) discharge characterization.

Administrative Demotions:

- A Staff Sergeant, 49th Aircraft Maintenance Squadron, was demoted to the rank of Senior Airman for failing to fulfill Non-Commissioned Officer responsibilities and standards.

Tip of the Month:

- PCS Out-Processing Fitness Assessment Requirement: Airmen have the responsibility to have a current Fitness Assessment (FA) through the Report No-Later-Than-Date (RNLTD) and 42-day acclimatization period. If your FA expires prior to the RNLTD + 42 days, the Airman must complete a FA before departing their duty station; Contact your Unit Fitness Program Manager to schedule testing before your departure.
