Below are actions taken at Holloman AFB during the month of November 2016.

Names are withheld when appropriate to the forum.

Courts-Martial:

- None.

Article 15 Actions:

- An Airman First Class, 49th Aircraft Maintenance Squadron, received an Article 15 for underage drinking. The member received a reduction to the grade of Airman, suspended reduction to the grade of Airman Basic, 10 days extra duty, and a reprimand.
- A Senior Airman, 49th Security Forces Squadron, received an Article 15 for driving while drunk and carrying an unauthorized firearm on base. The member received a reduction to the grade of Airman First Class, a suspended forfeiture of \$485.00 pay, and a reprimand.
- An Airman, 16th Training Squadron, received an Article 15 for providing alcohol to persons under the legal drinking age of 21. The member received a suspended reduction to the grade of Airman Basic, forfeiture of \$160.00 pay, and a reprimand.
- An Airman, 635th Materiel Maintenance Squadron, received an Article 15 for stealing a pair of headphones from the Base Exchange. The member received a suspended reduction to Airman Basic, forfeiture of \$200.00 pay, 26 days extra duty, and a reprimand.
- A Staff Sergeant, 49th Logistics Readiness Squadron, received an Article 15 for wrongful use of d-Amphetamine, a schedule II controlled substance. The member received a reduction to the grade of Senior Airman and a reprimand. The member appealed the NJP. The appeal was granted in part by suspending the reduction of grade to Senior Airman.

Administrative Discharges:

- A Senior Airman, 49th Force Support Squadron, was discharged for Minor Disciplinary Infractions. Member received an Under Honorable Conditions (General) discharge.
- An Airman First Class, 49th Maintenance Squadron, was discharged for Conditions that Interfere with Military Service. Member received an Honorable discharge.
- An Airman First Class, 49th Aircraft Maintenance Squadron, was discharged for Minor Disciplinary Infractions and Failure to Meet Fitness Standards. Member received an Under Honorable Conditions (General) discharge.
- An Airman, 54th Operations Support Squadron, was discharged for Sexual Assault. Member received an Under Honorable Conditions (General) discharge.
